PROMOTEEES ARE TO ENTER AT THE WEST SIDE ENTRANCE ON COLLEGE POINT BOULEVARD. PLEASE NOTE THAT GUESTS WILL NOT BE PERMITTED TO ATTEND. THIS INCLUDES FAMILY, FRIENDS AND CO-WORKERS. IN ACCORDANCE WITH OPERATIONS ORDER 85, S.20, ALL PROMOTEEES WILL UNDERGO THERMAL TEMPERATURE SCREENING AND BE PROVIDED WITH PERSONAL PROTECTIVE EQUIPMENT UPON ENTERING AND FOLLOW SOCIAL DISTANCING. PROMOTEEES ARE INSTRUCTED NOT TO ARRIVE PRIOR TO THE DESIGNATED REPORT TIME TO CONFORM WITH SOCIAL DISTANCING GUIDELINES.
