IN ACCORDANCE WITH OPERATIONS ORDER 85, S.20, ALL PROMOTEEES WILL UNDERGO THERMAL TEMPERATURE SCREENING, BE PROVIDED WITH PERSONAL PROTECTIVE EQUIPMENT UPON ENTERING AND FOLLOW SOCIAL DISTANCING. PROMOTEEES ARE INSTRUCTED NOT TO ARRIVE PRIOR TO THE DESIGNATED REPORT TIME TO CONFORM WITH SOCIAL DISTANCING GUIDELINES.
